GENERAL QUESTIONS

Who is the target group of the Green Gateway E-Learning courses?

The target group of the E-Learning are staff of financial intermediaries that implement EIB green windows and/or the EIF's Sustainability Guarantee.

Among this group, the primary target learners are front-office/sales staff. The content is however also relevant for other staff groups, in particular middle office staff engaged in green product development.

What is the benefit of participating in the Green Gateway E-Learning courses?

The courses provide brief and engaging introductions to target segments and requirements of EIB green windows and of the EIF's Sustainability Guarantee.

The courses serve as a starting point for learners who are new to the topic but are also useful for learners already familiar with the concepts covered.

Is it mandatory to complete the E-Learning courses?

The EIB Group does not require financial intermediaries and their staff to participate in the E-Learning. The E-Learning is a Green Gateway offer that can be taken up by financial intermediaries on a voluntary basis.

Individual financial intermediaries may however decide to make participation in the E-Learning courses mandatory for specific staff groups within their institution.

Whom can I contact if I have questions on the content of the Green Gateway E-Learning courses?

Generally, financial intermediary staff should contact the person within their institution that manages the implementation of the EIB green window and/or of the EIF's Sustainability Guarantee.

Those internal managers have access to additional Green Gateway knowledge material and can approach EIB Group experts with content related queries through the Green Gateway Helpdesk.

APPLICATION

What happens when I fill in the registration form?

A dedicated space within the E-Learning will be set up for your organisation. After the set-up of the dedicated space for your financial intermediary, you will receive an invitation from EIB advisory to you and your colleagues to sign up for the E-Learning.

Is the number of users limited?

The number of Green Gateway E-Learning users per financial intermediary is currently not restricted.

Is the information provided by our staff private?
